Agenda Item and Comments

03/10/01 – Minutes of the previous meeting.

03/10/03 – Matters Arising

Access to Village Hall

This matter is still ongoing. Cllr. Huckle had written to Newport City Council and was awaiting a response.

03/10/04 – Planning

CONEX/10/0128 PROPOSAL: SITING OF A TEMPORARY ON SITE RESIDENCE FOR A PERIOD OF THREE YEARS (RETROSPECTIVE) AFFECTING PUBLC RIGHT OF WAY 400/54 SITE: CEFN MABLY FARM PARK BEGAN ROAD CARDIFF CF3 6XL

The Community Council had no objections to make other than it does not approve of retrospective planning.

Local Development Plan

Newport City Council requires a response to the local development plan, Cllr. Phillips felt that there is a need for affordable housing in the area and that villages in general are losing smaller housing and rental opportunities. Cllr. Phillips then left the meeting as he has submitted Tinker's Field for development and has a personal interest. To comment on the preferred strategy of the LDP the Community Council's prime concern is the development of Tinker's Field. The general opinion of the inhabitants of the village was one opposing any development. This Community Council is against any development in open countryside and would like the LDP to reflect this.

Golf Course

Local resident John Winter has raised the issue of the proposed Golf Course in the village. He has employed his own planning consultant to look into the matter and then received a letter from the architects of Sir Stan Thomas that seem to undermine the promises made at the public planning meeting and also in writing to Cllr. Rowlands. He wanted it brought to the attention of the Community Council that firm assurances of looking into the impact upon adjacent premises and concerns of local residents made by Sir Stan Thomas seemed to be less certain and only stated that he would listen to our views. The Community Council wised to note these points for future reference should the need arise.

02/10/05 – Roads, Hedges, Verges and Bridges

Councillor Rowlands chased up the unfinished repairs on the bridge and had a successful result; repairs are now in the process of being completed. It was noted that now nearly all the roads in Michaelston Y Fedw have been resurfaced apart from Began Road which is the main bus route through the village

The need for another grit bin in the village was discussed again.
