06/15/01 – Minutes of the previous meeting.

The attending PCSO's informed the meeting that the PACT meetings have now been replaced with Your Voice, which is an online initiative to gauge policing concerns from the public. This has produced a far greater response and the current priority of the public is for the police to concentrate on speeding. Cllr. It may be an option to carry out our own speeding patrols but this involves being trained to use the equipment first.
